

Relyll™ is a soil surfactant formulated to establish consistent water flow into and throughout the rootzone. **Relyll** is easy to use and will not harm turf when used in accordance with product directions. When used as directed, **Relyll** can be applied at anytime of the year to avoid the detrimental impact of water repellency stress and localized dry spots on turf and to increase the vigorous appearance of turfgrass. **Relyll** is safe to turf when used as recommended.

DIRECTIONS FOR USE GENERAL TURF Greens, Tees, Fairways, Lawns and Sports Turf

Stress Management Program: Apply **Relyll** monthly at 4-6 fl.oz./1,000 ft² (120-180 mL/93 m²) in 2 (7.5 L) gallons of water. For best results, begin applications at least one month prior to the normal onset of stress conditions. While irrigation is not required immediately after application, best performance will be obtained if syringe cycle is applied to enhance **Relyll's** distribution into the rootzone. Irrigate before next mowing or leave baskets off.

High Stress Conditions: In areas where turf is subjected to high stress, apply **Relyll** monthly at 6 fl.oz./1,000 ft² (120-180 mL/93 m²) in 2 gallons (7.5 L) of water. When stress conditions subside, begin monthly applications at 4 fl.oz./1,000 ft² (120 mL/93 m²) in 2 gallons (7.5 L) of water. While irrigation is not required immediately application, best performance will be obtained if syringe cycle is applied to enhance **Relyll's** distribution into the rootzone. Irrigate before next mowing or leave baskets off.

Seeding: Apply **Relyll** at 4 fl.oz./1,000 ft² (120 mL/93 m²) in 2 gallons (7.5 L) of water two weeks prior to seeding.

Sodding: Apply **Relyll** at 4-6 fl.oz./1,000 ft² (120-180 mL/93 m²) in 2 gallons (7.5 L) of water to newly laid sod. Irrigate well to distribute **Relyll** throughout the rootzone.

DO NOT combine **Relyll** in the spray tank with pesticides or fertilizers unless prior use has shown the combination physically compatible, effective and non-injurious under local conditions.
